The Steering Committee met at MoHE with H.E. The Ministry Prof. Tweissi to discuss the outcomes of their first meeting with key Jordanian stakeholders and the level of advancement of the project's implementation. All members of the SC attended and the Minister ensured his full support to the NQF-J project that is seen as a strategic and top priority project for the MoHE and the Government.

The meeting confirmed the broad approaches being taken by the NQF-J project concerning:

- The number of levels within the NQF-J
- The audiences it seeks to address – and their overlapping but different needs
- The nature of the Descriptors to be used with the NQF-J
- The need for and nature of HE Discipline / Sector Descriptors
- The general approaches to the ways in which the NQF-J will be applied

And that these are in line with the needs and expectations of key Jordanian and international actors.
